4. All works must have a label, securely attached on the back, giving: Artist's name, Title of work, Medium, and Price.
5. No late entries accepted. Entry details cannot be changed after delivery.
6. Whilst all care will be taken by Gallery staff, MCAA accepts no responsibility for any damage or loss. Insurance is the responsibility of the exhibitor.
7. MCAA reserves the right to refuse any entry considered unsuitable for general exhibition.
8. MCAA acts as the agent for this exhibition and sale of artworks. A 25% commission will be charged on all sales.
9. All entries must be the original creative work of the Artist. Work **to be sold cannot be copied, either wholly or in part from any published article.** Personally owned photographs may be used as reference for subject matter.
